SNCT/16 SALARIES AND CONDITIONS OF SERVICE AGREEMENT PSYCHOLOGISTS

- 1. The SNCT has reached agreement on a pay increase to the Psychologists' scales with effect from 1 April 2001, 1 April 2002 and 1 April 2003.
- 2. Details of the changes to pay are contained in Appendix 1 to this circular.
- 3. From 1 August 2002 an additional contractual 35 hours of continuing professional development (CPD) will be introduced as a maximum for Psychologists. Details of these changes are set out in Appendix 2 to this Circular.
- Further work will be carried out by the SNCT with a view to reaching agreement on a new salary structure to be introduced from 1 August 2003 taking into account concerns raised in the Currie Report.

Changes to Conditions of Service – Psychologists

- 1. There will be no changes to conditions of service for Psychologists to that in the scheme of pay and conditions of service for Psychologists other than that an additional contractual 35-hours of CPD per annum will be introduced as a maximum for Psychologists. This shall consist of an appropriate balance of personal, professional development, attendance at nationally accredited courses or other CPD activity. This balance will be based on an assessment of individual need taking account of local and national priorities and shall be carried out at an appropriate time and place.
- 2. Every Psychologist will have an annual CPD plan agreed with her/his immediate manager and will be required to maintain an individual CPD record.
- It is recognised that a quality based framework for professional development will take some time to deliver and therefore Psychologists will work towards but not be expected to meet the full commitment until August 2003.
