## 1. SNCT Annual General Meeting 2022

# **1.1** Appointment of Joint Chairs:

## 2. Minute of Previous Meeting held on 23 February 2022

Point of accuracy. The meeting <u>agreed</u> that the minute of the previous meeting should be recorded as 27 May 2021 and not 30 September 2021.

Point of accuracy. The meeting <u>noted</u> that Mike Corbett attended the 23 February 2022 meeting of the SNCT as the representative from NASUWT and not Tara Lillis.

With these amendments, the minute of the previous meeting was <u>agreed</u> as a correct record.

COSLA <u>agreed</u> to include the names of the Councillor representatives in attendance in the final version of the minute.

## 2.1 Matters arising

There were no matters arising.

## 3. Pay Claim 2022/23 (update)

Des Morris, Teachers' Side Chair, reported that the Teachers' Side of the SNCT had unanimously <u>decided</u> to reject the 5% pay offer made by COSLA in its letter of 19 August.

On behalf of the Teachers' Side, Des Morris then formally declared a dispute with respect to the failure to agree the 2022 Pay Claim at the SNCT. This oral declaration of a dispute would be confirmed in writing by the Joint Secretary of the Teachers' Side later in the day.

The declaration of this dispute was a direct result of 5% being an insufficient offer and the delay in an improved offer being made by COSLA following an extended period of negotiation.

In response, Councillor McCabe, on behalf of COSLA, indicated that the budgets for Scotland's councils for 2022-23 contained no additional funds from Scottish Government to finance pay increases and that the consequences of any further increases would result in cuts to services or job losses which COSLA Leaders would not currently consider.

On behalf of Scottish Government, Sam Anson (Joint Chair) repeated the key messages from the Deputy First Minister's statement given to the Scottish Parliament on 6 September namely: the total Scottish Budget is fixed; the Scottish Government cannot vary income tax in-year; the reserve funding is fully allocated and the Scottish Budget is at the absolute limits of affordability.

All sides indicated their willingness to continue negotiations through Extended Joint Chairs with the hope of a negotiated settlement being reached. Councillor Katie Hagmann (Joint Chair) indicated that she would report the unanimous rejection of the 5% pay offer and the subsequent declaration of a dispute to the next meeting of COSLA Leaders. Sam Anson (Joint Chair) indicated that he would be reporting in similar terms to Scottish Ministers.

# 4. Report of the SNCT Support Group Meetings 22 March, 28 April and 31 May 2022

The Committee <u>noted</u> a report, which had been circulated in advance of the meeting, of the SNCT Support Group held on 22 March, 28 April and 31 May 2022. This report outlined the work undertaken.

### **Reduction in Class Contact Time**

The Teachers' Side set out its position that the reduction in class contact time should be used to increase preparation and correction time as this would have the most direct and beneficial impact on teaching and learning, attainment and teachers' excessive workload burdens. Scottish Government and COSLA representatives were asked to consider their position on this further and as a priority. It was agreed that discussion would be continued through a meeting of the Joint Chairs. In advance of that meeting, Scottish Government and COSLA representatives were requested by the Teachers' Side Joint Secretary to make clear their positions on the allocations of time following the reduction in class contact time.

## 5. Training for Job-Sizing Coordinators

The Committee <u>noted</u> a report, which had been circulated in advance of the meeting. This report confirmed that the SNCT had provided training for Job-Sizing Coordinators for the first time since before the pandemic. The offer of training had been taken up by most local authorities and over 2 days, 31 August and 7 September 2022, 68 participants underwent training.

Arising from the report, the SNCT <u>agreed</u> the following.

- 5.1 The training team should be asked to review the training undertaken and to develop training materials to reflect potential changes from the Job-Sizing Review Group, once that Group has concluded its work.
- 5.2 The issues raised by participants through course evaluation and questions during the training session should be considered by the Job-Sizing Review Group.
- 5.3 The commitment to future training to be delivered jointly and at least on an annual basis.

## 6. Report from SNCT Job Sizing Review Group 23 June

The Committee <u>noted</u> an oral update provided by Simon Cameron Employers' Side Joint Secretary) and agreed that a further meeting of the group would be arranged following the deadline for return of information from Councils.
