1. Minute of Previous Meeting held on 21 September 2022

The minute of the previous meeting was <u>agreed</u> as a correct record.

2. Matters arising

2.1 The meeting <u>noted</u> that Committee membership details had been provided to the Joint Secretaries.

- 2.2 Reduction in Class Contact Time. The meeting agreed to consider this item along with the report of the SNCT Support Group meeting held on 17 November 2022.
- 2.3 Job-Sizing Review Group. Simon Cameron (Joint Secretary) provided an update for the meeting indicating that the data requested had been received from most Councils. This information would be sent to the Job-Sizing Review Group for consideration at its next meeting.

3. Pay Claim 2022/23 (update)

Des Morris (Joint Chair) reported that the decision of Teachers' Side of the SNCT was to reject the revised pay offer made by COSLA in its letter of 14 February 2023. He also expressed its extreme disappointment regarding the manner in which the offer had been made. Both Scottish Government and COSLA representatives at the meeting offered apologies surrounding what appeared to have happened but gave assurances that information surrounding the details of the revised offer were not released publicly by either party and that it was not the intention that the offer should be in the public domain prior to its receipt by the Joint Secretary of the Teachers' Side.

Sam Anson (Joint Chair) expressed the disappointment of the Scottish Government that the revised offer had not been out to all members covered by the terms of the SNCT. On behalf of Scottish Government, he intimated its desire for negotiations to continue.

Councillor Katie Hagmann (Joint Chair) intimated that COSLA representatives will meet to continue negotiations and expressed the view of COSLA Leaders that the revised offer should be put to all members covered by the terms of the SNCT.

4. Pay Claim 2023/24

Des Morris (Joint Chair) submitted the following pay claim on behalf of Teachers' Side of the SNCT.

"The 2023/24 SNCT Teachers' Side pay claim is for a pay settlement which matches the rate of inflation, plus a significant pay uplift beyond that to address restoration of the value of the teachers' pay."

The Joint Secretary of the Teachers' Side would confirm this claim in writing to the other Joint Secretaries following the meeting.

5. Report of the SNCT Support Group Meetings 17 November 2022.

The Committee <u>noted</u> a report, which had been circulated in advance of the meeting, of the SNCT Support Group held on 17 November 2022. This report outlined the work undertaken.

Reduction in Class Contact Time

The meeting noted that the SNCT Support Group had recommended that discussion should be continued through discussion with the Joint Chairs as no agreement had

been reached on SNCT implementation through the mechanism of the SNCT Support Group.

The Teachers' Side set out its position that the reduction in class contact time should be used to increase preparation and correction time as this would have the most direct and beneficial impact on teaching and learning, attainment and teachers' excessive workload burdens. Scottish Government and COSLA representatives were asked to consider their positions and to provide written proposals in advance of the proposed meeting of the Joint Chairs.

The Joint Secretaries were asked to consider the date and time of this meeting of the Joint Chairs. These discussions could involve either scheduling the meeting on the same day as the next meeting of the SNCT Support Group on 23 March 2023 or as a replacement for that meeting.
