Des Morris (Joint Chair) reiterated the teachers' side view that the reduction in class contact time must alleviate workload issues and conveyed their disappointment around the lack of progress and failure to agree, as yet, on the use of this time. He requested an urgent response from SG and COSLA as to their position on delivery timescale and the use of class contact time reduction prior to the forthcoming EIS conference.
