(2) <u>Welcome</u> – The Chair welcomed members to the meeting and invited introductions from around the table.

## (3) SNCT Annual General Meeting

(a) Joint chairs for 2010/2011 were appointed as follows:

(c) All sides then agreed to notify their final membership of the SNCT for this year via the Joint Secretaries.:

- (d) The SNCT will continue to use Condie's, (COSLA auditors) if required.
- (4) <u>Note of previous meeting 19 January 2010</u> This note was <u>agreed</u> and it was also <u>noted</u> that the outstanding issue at item 6 would be discussed later in the agenda.
- (5) Reports of SNCT Working Groups:
  - (a) The Report of the Conditions of Service Working Group was <u>agreed</u> and it was <u>noted</u> that thanks was due to the group for the considerable work undertaken to agree the Circulars due to be homologated later in the agenda.
  - (b) The Report of the Review of LNCTs Working Group was <u>agreed</u> and it was <u>noted</u> that further reports would be made at a future meeting to provide updates on the numbers of local agreements uploaded to the website as well as the arrangements put in place for the future maintenance of the website itself.
- (6) <u>Headteacher Recruitment and Retention Report</u> Following discussion, it was <u>noted</u> that the Joint Secretaries had not yet had time to fully consider the 2 recommendations of interest to the SNCT and would now provide their report to the next full meeting of the SNCT.
- (7) <u>SNCT Circulars</u> The following circulars were <u>homologated</u>:

- (a) SNCT 10/17 Health Professions Council. Although happy to homologate this circular, the teachers' side wished to <u>note</u> the need to monitor the process and to consider the matter further in the event of unnecessary delays in the accreditation and registration of probationer educational psychologists seeking full registration with HPC. The employers' side also wished to <u>note</u> the need to monitor the effect of removing the requirement that educational psychologists be chartered from the handbook, in relation to the support which needs to be provided to newly qualified staff.
- (b) SNCT 10/18 Annual Leave, Sickness Allowance and Notification Procedures and Family Leave. Again although happy to homologate this circular the teachers' side wished to <u>highlight</u> that no provision had been made for backdating these entitlements and that there was therefore possibility of this being challenged by individuals affected.
- (8) <u>Memorandum of Understanding with GTCS</u> The final draft of this was <u>noted</u> however there was no signing ceremony due to the absence of the employers' side Joint Chair. It was agreed that the signing would take place at a future date.
- (9) <u>SNCT Calendar of Meetings 2010 2011</u> The draft calendar was <u>noted</u> and will now be finalised by the Joint Secretaries.
- (10) AOCB There was no other business to be discussed.
