### 1. Minute of previous meeting – 29 May 2014

The minute of the previous SNCT meeting was agreed as a correct record. There was no business arising.

#### 2. <u>Conditions of Service Working Group</u>

The meeting noted a written report on the work of the group which was circulated in advance. The report covered pay and leave arrangements,

shared parental leave, comments from the GTCS on Handbook revisions, SNCT provisions on practical classes arising from new qualifications and the pay arrangements of Former Senior Teachers and Assistant Principal Teachers.

# 3. LNCT Review Group

The meeting noted a written report on the work of this group which was circulated in advance of the meeting under the following headings:

It was agreed that further work would be conducted around identifying what steps Councils were taking in relation to conservation, with an updated report to be brought to the next meeting of the SNCT.

5. Uprating of the Remote Schools and Distant Islands Allowances

The meeting agreed the recommended approach to uprating the remote and distant island allowances as set out in the written report. The allowance will be based on the ONS figure for the increase in Average Weekly Earnings (total pay) over a three month average. The months April and October will continue to be used for the Remote Schools Allowance and Distant Island Allowance respectively. The meeting also agreed that in calculating three monthly averages the three months directly preceding should be used.
