1. <u>Minute of the SNCT held on 30 September 2014</u>

The Minute of the meeting of the SNCT held on 30 September 2014 was approved as a correct record. There was no business arising.

2. <u>Extended Joint Chairs Meetings</u>

The meeting <u>noted</u> an oral report on the progress of pay discussions through the Extended Joint Chairs mechanism. There have been a total of 5 meetings of the group and discussions are continuing. The next meeting is scheduled for Tuesday 17 March 2015. Tom Tracey outlined a response from the Teachers' Panel to an offer from the Employers' Side dated 3 March 2015.

3. <u>Report of Conditions of Service Working Group 26 February 2015</u>

The meeting <u>noted</u> a written report on the work of the group which had been circulated in advance of the meeting. The Conditions of Service Working Group has approved a revised Family Leave section for the SNCT Handbook (Part 2, Section 7). This is principally to address the introduction of Shared Parental Leave from April 2015. The Working Group also agreed to look at an issue relating to continuous service when teachers and associated professionals move Councils during qualifying service for maternity pay. The Teachers' Side <u>noted and welcomed</u> the significant progress that had been made in aligning the pay year and leave year to commence at the start of the academic session in each Council area. The SNCT <u>agreed</u> that a meeting would be organised with SPPA before finalising the specification and promulgating Handbook changes.

4. Report on Review of LNCTs Working Group 15 January 2015

The meeting <u>noted</u> a written report on the work of the group which had been circulated in advance of the meeting under the following headings:

- SNCT Website: LNCTs have been asked to review their current local agreements and to update the SNCT website.
- Conservation of Salaries: The Working Group agreed to ask Councils to provide a further update on the number of employees facing a potential drop in salary on 1 April 2016 arising from the removal of lifetime conservation.
- Teacher Workload: The Working Group agreed to put general guidance on the SNCT website and to approach specific Councils for certain documents for further consideration by the Group and publication on the SNCT website.
