SNCT/38 **Residential Special School Allowances**

1. It was intimated in SNCT/2 that the additional duties paid for through the residential responsibility allowances would be covered through job sizing. Having considered this during the development of the job sizing toolkit the SNCT concluded that this was not possible.
2. The SNCT has therefore now reached agreement on revised allowances paid to teaching staff in residential special schools with effect from 1 April 2004.
3. The allowances paid to teaching staff in residential special schools are increased as follows:
